



We visited Kerwin late last night and have arrived at the ICU again this morning. There is a remarkable improvement in the past 12 hours. He is much more alert/awake as you'd expect, though it was rough overnight due to the nausea. The nausea seems to be subsiding this morning--probably a combination of the anti-nausea medications and the normal metabolism of those drugs in his system--and they fact they gave him a fluffier pillow. Kerwin is cracking a few jokes, but is still unable to open his eyes for more than a second or two due the dizziness--normal for the first few days, according to the doctors.

We expect Kerwin to remain in the ICU through today; the docs say it is likely they will move him to the step-down recovery area tomorrow at some time. We're still a few days or more from him being released to go home. I'll pass along those details/ room# as soon as I can.

Again, thank you all for your thoughts and prayers.

Aloha All......today we lost another American Hero, Sgt Major Jon Cavaiani, Medal of Honor recipient while serving with MACV-SOG, 5th Special Forces Group, Vietnam 1971. Jon was also a POW and was held for two years by the North Vietnamese. Jon had a great sense of humour and was a highly recognized and noted "Master Chef" who was in demand by the rich and famous for his outstanding cuisine. Jon was most proud of his "Eagle, Globe and Anchor" that he cherished and wore on th...e top right lapel of his uniform. Our Marine Corps Commandant, CMC, recognized Jon as an "Honorary Marine" of which Jon was most proud as only a handful have received this distinguished "Honor." Jon was born

in England but proud when he became a naturalized citizen in 1968. Jon resided in Columbia, California but will be laid to rest with Full Military Honors at Arlington National Cemetery. He will be missed and prayers airborne to bring comfort to his wife and family.
